Instructions to complete the Annual Declarations of Anticipated Activities in 2026*

*according to the [Chemicals Control Ordinance \(ChCO\)](#) of 21 August 2013 (status as of January 1, 2022, SR 946.202.21)

1. Who shall declare?

Production, Processing and Consumption

A plant site is declarable as soon as the amount of *production, processing or consumption* of a [Schedule 2](#) chemical exceeded a certain threshold in any of the previous three calendar years or presumably will exceed it in the next calendar year. The threshold for a Schedule 2A* lies at 1 kg, for a Schedule 2A at 100 kg and for a Schedule 2B at 1000 kg (see table 1a).

A plant site is declarable as soon as the amount of *production* of a [Schedule 3](#) chemical exceeded a threshold of 30 tonnes in the previous calendar year or presumably will exceed it in the next calendar year.

For **DOCs**¹ (Discrete Organic Chemicals) and PSF (Phosphorous, Sulfur and Fluorine) chemicals the declaration of anticipated activities is not required.

In case of mixtures of scheduled chemicals, one has to declare their effective weight and for the conversion to 100 %, the concentration of the listed chemical must be taken into account. If you have Schedule 2A chemicals to declare, please consult article 27 (Schedule 2 chemicals in mixtures and as intermediates or by-products) of the [Chemicals Control Ordinance](#). The chemicals of Schedule 2B and Schedule 3 are declarable if the concentration is higher than 30 percent by weight (w/w-%) (see tables) and the calculated amount exceeds the threshold in table 1a.

3. General comments

The declaration applies exclusively to activities within Switzerland or the Principality of Liechtenstein. Referring to the obligations stipulated in the Chemicals Control Ordinance (ChCO), declarations are required for a plant site pertaining to production, processing or consumption. Figures on imports and exports are not required, except on form 2.5 in the case of direct exports from your plant site.

You will find the appropriate codes required in the different declaration forms under point 6 of this guide.

In order to ease the declaration procedures for your company we have partly filled in the data based on the information in the previous declaration. Therefore, please verify the data that has changed since the last declaration as it is your responsibility to correctly complete and declare the anticipated activities. We kindly ask you to date and sign every page of the form and return them to the “Meldestelle für Chemikalien” before the deadline.

Form 2.3.2 is only required in the case of production of a Schedule 2 chemical and has therefore only been sent to the plants concerned.

4. Confidentiality

All Information is treated as classified. Declarations submitted to the international Organisation for the Prohibition of Chemical Weapons (OPCW) are classified and protected accordingly by the Organisation.

5. Definitions

Production of a chemical is defined as its formation through chemical synthesis or a bio-chemical or biological process; for declarations, this includes intermediate, by-products and waste products.

Processing of a chemical is defined as a physical process, such as formulation, extraction or purification, in which one chemical is not transformed into another; repackaging or filling of a chemical is not covered by this definition.

Consumption Transformation of a chemical into another chemical through a chemical reaction or through a bio-chemical or biological process; for declarations, this includes the destruction of waste products

Plant site is defined as the local integration of one or more plants, with any intermediate administrative levels, which are under one operational control, and which includes a common infrastructure.

Plant is defined as a relatively self-contained area, structure or building containing one or more units with auxiliary and associated infrastructure.
